As a valued member, you are invited to participate in the **73rd Annual Members' Exhibition** at the Quinlan Visual Arts Center, Gainesville, GA. This much-anticipated exhibition opens October 8, 2020 and runs through December 5, 2020. Members wishing to participate must have a CURRENT membership valid through December 25, 2020. Juror and most celebrated artist, Steve Penley will award ribbons for *Best in Show*, *First*, *Second*, and *Third* places as well as several *Honorable Mentions*. Exhibition reception and Award Ceremony dates TBD, due to the pandemic. As we are not permitted to hold gatherings larger than 50 persons, we will schedule several outdoor receptions throughout the Members' Exhibition. During receptions, patrons will be able to enter our gallery spaces, observing social distancing.

You may submit **ONE** piece in this show (no size restrictions). Pieces in all media are acceptable. Please submit **TWO** copies of the completed entry form (enclosed). Attach one copy to the back of each piece, and bring the signed, initialed original with delivery.

All two-dimensional pieces should be wired and ready to hang. No previously exhibited (upstairs at the Quinlan) pieces are eligible, all artwork must have been created in the last five years, and entries must be delivered between Monday, September 28 – Friday, October 2.

Due to the overwhelming popularity of this exhibition, the Exhibitions Committee will make the final determination of what appears in the show.

Artwork must be picked up between Saturday, December 5 and Monday, December 7. We have limited storage capacity so all artwork not picked up by January 2, 2021 will become the property of the Quinlan Visual Arts Center.

Thank you for making the Quinlan the thriving visual arts organization it is today. While the pandemic has placed many non-profits in a precarious position, the Quinlan has been blessed to keep its doors open thanks to you and your contributions! Next year, the Quinlan turns 75!
