### ELIGIBILITY

Open to all members and non-members 18 years or older, residing in the following states: Georgia, Florida, Alabama, South Carolina, North Carolina, Tennessee or non residents belonging to a district chapter of CPSA within these states.

### ENTRY FEE & CD ENTRY INFORMATION

Entry fees are non-refundable. No preferential consideration is made during the judging process between members and non-members. Artists may submit one to three pieces on one CD for the following fees: CPSA members \$25 - non-members - \$30 . CD's must be postmarked by January 11, 2010. Accepted entries will be listed on [www.cpsa.org](http://www.cpsa.org), February 9, 2010.

Print your name on the top of the CD. Along with the image please include title, size of unframed image and artist's name. Mark according to Exhibition Entry Form.

### SPECIFICATIONS

- Entries may be 100% colored pencil or may include up to 25% other media, including watercolor, acrylic, oil, ink, pastel, etc. 3D is acceptable as long as the work is primarily colored pencil.
- Must be of original design, no copies of other artwork or published photos. No prints.
- Framing should be simple and must have wire for hanging. Mats should be neutral -white, off-white, cream, gray, tan or black. Double matting is acceptable with an inner mat of color.
- If the artwork is hand delivered glass is acceptable but not for shipped works. Frame size not to exceed 34" by 42".
- Artwork that has been previously accepted into a CPSA International exhibit cannot be entered. Explore This! accepted entries are allowed.
- All information given on entry form must remain the same. Artwork should not be altered once accepted. The jurors and CPSA 107 reserve the right to disallow a painting if it does not meet the above criteria.

### SHIPPING

Artists are responsible for shipping expenses to and from exhibition in sturdy reusable cartons. Strongboxes (such as from Airfloat 1 800-445-2580) are highly recommended. Prepaid return shipping labels must be included if not to be picked up. **NO POPCORN IS TO BE USED IN SHIPPING.** If artwork is not shipped using these guidelines it may be returned at the artists expense. Groups may want to compile artwork and have one person deliver it to the Quinlan or to a CPSA 107 Atlanta member.

### LIABILITY

Every precaution will be taken to protect artwork. Quinlan Visual Arts Center , CPSA and CPSA 107 Atlanta will not be responsible for any work delivered in damaged condition. The Quinlan insures artwork while it is on their premises. Artists may want to insure their own work and are responsible for contacting their own insurance agent prior to shipping.

### AWARDS

First place \$500, other awards to be announced. Awards and honors will be presented at the reception and posted on the CPSA 107 Atlanta website, [www.cpsa.org](http://www.cpsa.org). Winners will be notified by phone if possible.

### DIMENSIONS

**1024 x 1024 at 72 pixes per inch.** Image should be centered with black fill on either side of the shorter dimension.

### FILE FORMAT

Save image as a baseline **JPG** file with a **quality of 8** or **(High)**. DO NOT save as a PROGRESSIVE JPG file. Size of the file should be less than 500 KB.

### FILE NAMES

JPG file names should include the correct file extension (.jpg) and indicate whether you are submitting one or multiple images. Please use the following example.

### Dr. Robert Westervelt . . . . . Award Judge

Dr. Westervelt received his BS from Williams College, MASS; his MFA from Claremont Graduate School and Scripps College, CA; and his PhD from Emory University in Atlanta, GA. His PhD focus was on "Aspects of American Painting." Dr. Westervelt taught at San Bernadino Valley College, CA; Agnes Scott College, GA; and he was the Chair of the Art Department for Gainesville State College. Dr. Westervelt has been juror at numerous regional and national art shows, including the Atlanta Watercolor Society. His pottery work is displayed in museums around the country, including the Smithsonian, High Museum of Art, Syracuse University, and DeGado Museum of New Orleans.

Dr Westervelt has authored an illustrated computer book entitled An Insider's View of Art completed recently and awaiting publication.

### Dr. Delores Diaz . . . . . Inclusion & Award Judge

Dr. Diaz worked for 32 years as a secondary teacher in public schools. For 6 years, she served as an adjunct professor at Gainesville State College & North Georgia College, teaching graduate and under-graduate art education and art history. She is a current member of the Quinlan Visual Arts Center Board of Trustees and Chair of the Educational Programming Committee. Dr. Diaz is a current art education consultant for the Georgia Council for the Arts; served on NAEA Editorial Board and Review Panel for the Art Education Journal; and served on the Brenau University Gallery Board as Education Committee Chair. Dr. Diaz has juried numerous art exhibitions.

Dr. Diaz has exhibited oil and encaustic paintings in faculty exhibits at NGCU and at GSC. She has exhibited with a consortium faculty exhibit at Ben M'sik University in Casablanca, Morocco.
