All two dimensional pieces should be **wired and ready to hang**. No previously exhibited (upstairs at the Quinlan) pieces are eligible, all artwork must have been created in the last five years, and entries may be delivered between **Monday, October 12 and Friday, October 15.**

Due to the overwhelming popularity of this exhibition, the Exhibitions Committee will make the final determination of what appears in the show. Artwork should be picked up on Monday, December 7. We have limited storage capacity so all artwork not picked up by January 3, 2016 will become the property of Quinlan Arts Inc.

Thank you for making the Quinlan the vital visual arts organization that it is today. We look forward to your joining us in what will be one of the most exciting exhibitions of the year.
