RULES AND REGULATIONS

Artwork Requirements:

Work must be original in concept, composition and execution. Artwork must not be copied, in part or wholly, from any published or copyrighted work.

Sale of Artwork and Commission:

The QUINLAN VISUAL ARTS CENTER cannot guarantee the sale of art, but every reasonable effort will be made to promote and encourage artwork sales*. Payment for work sold will be sent within thirty (30) days of exhibition closing. The artist's share will be 60% of the retail price listed on the inventory sheet. A 40% commission will be retained by the QUINLAN VISUAL ARTS CENTER. *Artwork will be sold at the retail value indicated by the artist on the inventory supplied at art delivery. There will be **no** discount given on any pieces without the expressed permission and agreement of both the artist and the executive director of the QUINLAN VISUAL ARTS CENTER.

Shipping/Delivery: Art Delivery: June 24—28

Accepted artists will be responsible for shipping/delivery. Artist will be responsible for the cost of shipping, unsold artwork that was shipped will be returned at the cost of the QUINLAN. *All inventories being shipped need to be approved, in writing, by executive director.*

Media Release:

There may be photographers and/or television crews to photograph or film the QUINLAN VISUAL ARTS CENTER exhibitions. QUINLAN ARTS INC. reserves the right to photograph artwork for publicity purposes, for reproduction in relevant publications and website. Artist hereby gives permission for resulting promotional photographs and television and/or television footage of both artist and artwork to be used for promotional purposes on television, newspapers, magazines, press releases, on the arts center website or any other present or future media deemed appropriate by the Board of Trustees of the QUINLAN VISUAL ARTS CENTER.
